_____ 30 Minutes of prep time is included before the party start date

_____ Party guests are only able to use the spaces that are agreed upon and reserved in advance

_____ I am aware that the Birthday Party is for a total of 20 Guests (this includes children and adults. Parties of 21-40 people will be charged an additional \$50)

_____ I am aware that all guests must sign the guest waiver form upon entry to the party
